MINUTES:

Motion was made by Mr. Davis and seconded by Mr. Sheppard that:

The Minutes of October 1, 2012 be approved with the recommended changes
Motion was voted 3-0-1 (Mr. Ryan abstained due to not being a member at that time)

EOC STAFF – HURRICANE SANDY, October 29th:

Town Hall was closed on Monday, October 29th due to Hurricane Sandy. A number of department heads had worked Emergency Operations Command from morning to late into the evening.

Motion was made by Mr. Sheppard and seconded by Mr. Ryan that:

To demonstrate our appreciation the Board is in support of giving the department heads who worked on the EOC personal time based on Town Administration's recommendation. However, this will not occur on every time that the EOC has to meet again.
Motion was voted 4-0, unanimous.

REVISED EMPLOYMENT APPLICATION:

HR Administrator has drafted a revised employment application which request more detail from the applicant who is applying for a position.

Motion was made by Mr. Davis and seconded by Mr. Sheppard that:

The Board approves of the revised employment application as submitted.
Motion was voted 4-0, unanimous.

FY2014 COST OF LIVING INCREASE:

Members reviewed the New England and Boston CPI which reflects 1.7% COL for September. They also reviewed the chart that reflects the cost of living increases for the town and school unions. Based on that information

Motion was made by Mr. Davis and seconded by Mr. Ryan that:

The Board recommends 2% cost of living increase effective July 1, 2013.

Motion was voted 5-0, unanimous.

The Board members also discussed the benefits that are offered to town and school personnel. Mr. Davis and Mr. Hinds requested a pie chart that reflects current staffing of all town and school employees. Mr. Hinds also requested a list of positions that were eliminated over the past 10 years.
